

"100% of students who are deaf or hard of hearing may attend CID with 100% tuition support."



With this statement, in May 2022, the CID board approved a new plan to ensure that all eligible children with hearing loss receive a CID education without their families facing the burden of tuition. Once the resolution was approved, our admissions team shared the exciting news with several prospective families touring CID. We're confident that 100% tuition coverage will bring more opportunities for children who are deaf or hard of hearing to attend CID.

Another exciting development happened behind the scenes. Our data solutions project, initiated several years ago by a few generous and visionary donors, developed into something really special. We used the low-code/no-code data programs Knack and Hearform to document and more easily track and compare child and family demographics, interventions, outcomes and more. Each passing month brought new ideas about how we might look at these data to yield previously impossible insights into language, speech and academic progress. Later in the year, our program evaluation team began learning a new program – PowerBI, which has unlocked our imaginations. We look forward to new and meaningful ways to visualize and learn from data to enhance our work with each individual student and improve the effectiveness of our programs.

Finally, this year we took the opportunity to spread the word about CID's longstanding mission to thousands of commuters who travel through our backyard every day. An eye-catching photo of two students in CID's Anabeth and John Weil Early Childhood Center greeted drivers along Highway 64/40 during May. One of the children – Zeke – is the child of two deaf parents and the brother of a deaf sibling who also attended CID. The family chose CID so their young children could learn listening and spoken language, and speak fluently, opening opportunities for a limitless future. The bright yellow earmold pops with vibrant color, but it pales in comparison to the smile beginning to cross Zeke's face as his buddy shares a secret. We're certain it brought joy to drivers stuck in rush hour traffic even as it showed them that deaf children can learn to listen and talk!

FUNCTIONAL LANGUAGE

Goal: By the end of each semester, 80% or more toddler class students will use spontaneous words in one or more new functional language categories such as requesting objects, greeting, commenting, protesting, asking for attention and/or maintaining the ability to use words.

NEW INDICATOR

Goal: By the time they age out of toddler class, 80% or more students will have moved from gestures and vocalizations to unprompted word use in eight functional language categories.



VOCABULARY NEW INDICATOR

Goal: 80% or more children between 8 and 30 months old who have received two or more MacArthur-Bates Communicative Development Inventories (MB-CDIs) will at least double the number of expressive vocabulary words they can produce over a six-month period of time.

STANDARDIZED TESTS

In 2021-2022, it's worth celebrating that every returning preschooler at CID maintained or improved scores across standardized tests of skills foundational to their learning and ongoing success.

Although numerous factors vary in the student population from year to year, this outstanding result is a clear testament to the hard work of the children, their parents and families, teachers, audiologists, speech-language pathologists and support staff.



All returning preschoolers made at least a year of progress and/or tested average or above compared to same-age children with typical hearing.

During 2021-2022, most returning CID primary school students maintained or improved scores across standardized tests of skills foundational to their learning and ongoing success.


PHONICS CURRICULUM

CID students learn to read the same way other children learn to read – by correlating the sounds they hear with letters and groups of letters on a page. Because they may not hear all of the sounds of speech, children with hearing loss often need extra help to develop this fundamental skill.

In the spring 2022 semester, all CID teachers received training on SPIRE, a curriculum that employs phonics



to support reading skills. This initiative is expected to help our school-aged children improve their reading scores as they prepare to attend mainstream educational settings.
